

# Privacy Policy

This Privacy Policy ("Policy") applies to [www.shesinnovation.com](http://www.shesinnovation.com), and SHES Innovation ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include [www.shesinnovation.com](http://www.shesinnovation.com). The Company's website is a Information and consulting services site. By using the Company website, you consent to the data practices described in this statement.

## Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name

## **Sharing Information with Third Parties**
